

Steamboat Marathon & Half Marathon 2009 Registration Transfer Form

In consideration of the acceptance of this entry in the 28th Annual Steamboat Marathon, Half Marathon, 10K and/or Fun Run, I release the Steamboat Springs Chamber Resort Association, Inc., the race directors, and any sponsor of the races and their respective officers, members, agents and employees for all actions, claims and demand of any kind and nature that may arise from or in connection with my participation or proposed participation in any aspect of the races accepting the risks involved including but not limited to those risks involved with road racing such as dehydration, heat exhaustion and sharing the road/race course with motor vehicles during the race, and waiving all rights of any kind that might otherwise exist. In addition, I waive any claims I might have in connection with cancellation of the races for whatever reason. I represent that my physical condition to the best of my knowledge, is adequate to compete safely in a distance race. I authorize and consent to the publication by the SSCRA, whether by television, newsprint, written advertisements or otherwise, of any materials containing my name or

picture, and I release to the SSCRA, Inc. and all persons acting under authority from it any claim I might have due to initial or subsequent publications of such material. I sign on behalf of myself and my heirs, personal representative and assigns.

I understand that by filling out this Transfer Registration form I have come to an agreement with another runner to purchase their guaranteed entry. The financial transaction for the entry fee and exchange of entry confirmation card is strictly between the transferring runner and the person with the entry. The transfer runner must send in a completed Transfer Registration form with a valid runner confirmation card/email or a copy of the original owner's Driver's License, and a check for \$10 for the transfer fee to SSCRA postmarked on or before May 27, 2009.

Transfers will not be processed at bib pickup. No exceptions. Please check the Steamboat Marathon web site before the race to confirm that your transfer went through.
